Politics: Can Swiss nationals be represented in the Federal Assembly?



During the last OSA (Organisation of the Swiss Abroad) meeting Vincent Croset – one of the newly elected delegate living in the UK – has proposed launching an initiative in order to allow the Swiss National councils to have representatives of the Swiss abroad.

Thanks to the support of Loredana Guetg-Wyatt (UK), Daniel Plumet (France), Stéphanie Leu (France) and Constantin Kokkinos (Greece), a 'discussion group' has been formed with the common aim of understanding how to realise this objective.



'We have discussed three main aspects so far: the first one is what would be the advantages and disadvantages of having a better representation of the Swiss abroad in the parliament, and why we need it' explained Mr Croset . 'The second important issue is how it would happen in practice (how many representatives, who would elect them, how does the Constitution need to be changed, etc), and the last is how to construct a strategy for making this acceptable to the parliament and the Swiss people'.

In particular, the initiative could stumble at the Council of States, because those Swiss nationals living abroad cannot literally represent a canton at the moment. The proposal could not consider the possibility of the creation of a '27th canton', which would need to be a geographical entity, with a local government.

The new 'representatives' could easily join the lower house but it would unbalance the power of the upper house giving rise to several legal issues and problems linked to the changing of the constitution and the electoral law. This is one of the main reasons why the motion presented by Mario Fehr (SPZH) and a parliamentary initiative submitted by Carlo Sommaruga (SP-GE) were rejected by the Council of States in 2007.

'Of course, having National Councillors representing the Swiss abroad would be a big constitutional change but in many countries, citizens from abroad can be represented in the parliament, so they have a real voice! About 10% of Swiss citizens live abroad, and they need to be represented by people who know of their situation and concerns, which are often different from those of people living in Switzerland. Representation would also help Swiss expats to keep ties with the political life of their country of origin. Things always take time to change in Switzerland, so we will have to be patient. But I am confident that this will eventually happen'.

issues of e-Voting as well as pushing parliament to bring into law, the right of every Swiss national living abroad to have a bank account with a recognised Swiss bank. We are currently working hard on updating the FOSSUK constitution, primarily to cater for the now five UK Delegates (four until this year) and there will be many other important issues that need voting on.

Northern Ireland: 'Brexit brings uncertainty to local and foreign citizens'



Franziska Hewitt has been the Honorary Consul for Northern Ireland since 2011. She lives in Belfast with her husband and works as a psychotherapist for children and families with mental health issues. She attends, with passion, to the needs of the small, but united Swiss diaspora living in

the country. We have spoken to her about our compatriots' lives in this special moment for Northern Ireland.

How many Swiss people are living in Northern Ireland and what kind of professions are they engaged in?

There are 184 registered Swiss citizens resident in Northern Ireland (NI), working in a variety of jobs. We have, for example, a train manager, a health food shop owner, an accountant, a church minister, an electrical engineer and a tour guide. There are others who work in the textile industry. There are also some retired people and of course children. Some family members are $3^{\rm rd}$ generation immigrants.



Some moved here for work, others for family reasons or because they liked the quality of life. The Swiss I have met in NI are modest, kind and caring people. They seem to appreciate and blend in very well with the down-to-earth, helpful, humorous nature of the local people who, in turn, appreciate us for our reputation of being caring, reliable, neutral and hard workers..

Northern Ireland is a country that has suffered very much during the ages. What are the most important changes happening now?

At the moment we do not have a local government because the two most prominent and politically opposite parties have not yet been able to find a joint way forward. At the same time Brexit lies ahead. This situation brings uncertainty for businesses, public services and the movement of people. Many people are concerned about the economy getting weaker post-Brexit, the reintroduction of border controls and negative effects on the peace process.

In your understanding, what kind of concerns do Swiss people in NI have concerning the Brexit negotiations?

Northern Ireland is the only part of the UK with a land border with the EU, namely with the Republic of Ireland. In recent years the border has become less visible, and this has impacted on travel between the north and south for all kinds of reasons – trade, tourism, education and even medicine. This has been a contributing factor to the progress of the Northern Irish peace process.

In my view the prospect of Brexit brings uncertainty to local and foreign citizens in the province. Swiss people have expressed concerns in relation to business, the economy and prosperity. They worry that public services may be under increased pressure. They want to know what Brexit will mean for the movement of people.

The Swiss Embassy is closely following the developments around Brexit and is working hard alongside the competent Swiss authorities to conduct a dialogue with the UK government to safeguard the rights and obligations of the members of the Swiss community in the UK.

Embassy News: Brexit – Ensuring continuity in the Swiss-UK relationship

The UK's departure from the European Union will have a considerable impact not only on the UK itself, but also on third countries such as Switzerland in general, and the Swiss community living in the UK in particular. The Embassy is closely following developments around Brexit, and in implementing the Swiss government's 'Mind the Gap' strategy aims to safeguard the existing mutual rights and obligations between Switzerland and the UK after the UK's withdrawal from the EU, and to strengthen the bilateral relationship in all common areas of interest.

Switzerland and the UK enjoy a strong relationship, which is evident from the impressive economic footprint the two countries share. This close relationship that unites us is rooted in Switzerland's many bilateral agreements with the European Union and the UK's membership of the EU. Once the UK leaves the EU, this framework disappears from our bilateral relations. It is the

Embassy's task to help establish a replacement regime that will be effective on the day the UK leaves the EU. Since the Brexit referendum, the Embassy has been in constant contact with the UK government, and has helped the competent Swiss authorities to conduct and coordinate a dedicated dialogue to ensure continuity in all areas of our bilateral relationship - ranging from trade, transport, migration and education to research, data protection, financial services and the fight against fraud. These discussions also encompass the question of citizens' rights: the Swiss government has engaged in a close dialogue with the British authorities to ensure continuity and the protection of acquired rights of Swiss nationals living in the UK (and vice-versa) under the bilateral Agreement on the Free Movement of Persons. On 11 December the UK Prime Minister wrote an open letter to EU, EEA and Swiss citizens living in the UK. In the letter, Theresa May pointed out that the UK is working closely with Switzerland to ensure



that Swiss citizens living in the UK will also benefit from the arrangements between the UK and the EU. According to these arrangements, a new immigration system will be introduced under which all EU citizens will have to register for so-called 'settled status', which will presumably also apply to Swiss citizens living in the UK.

The Embassy is intensively working not only to avoid a 'cliff edge' in our strong economic relations, but also to safeguard the 'acquired rights' of the members of the Swiss community in the UK. For more information visit: www.eda.admin.ch/london -> FAQ Brexit

Unione Ticinese: The Swiss-Italian 'stuccatori' who made the British mansions great

Plasterworkers, or *stuccatori*, from villages on the southern shores of Lake Lugano were perhaps the first distinctively Ticinese group to make their mark in England. Between about 1720 and 1760, they were responsible for the flamboyant plasterwork in numerous British and Irish stately homes and the more subdued plasterwork in churches, notably St Martin's-in-Fields, which looks out onto Trafalgar Square.

On Tuesday 26 September a group of 18 members of the Unione Ticinese, with friends, were lucky enough to be given an in-depth tour of Ditchley Park in Oxfordshire. It contains some outstanding work by the stuccatori but is normally closed to the public. The house stands in the midst of handsome and abundant parkland set in rolling countryside, well populated with cattle. The house was built for a grandson of Charles II in the early 1720s but the splendour one might expect is hidden within the walls. From the outside it looks the paradigm of a medium-sized but elegant English country house with an understated central block connected to smaller buildings on either side by short, curving colonnades.

The tour was expertly led by Mike Montagu, the bursar of the Ditchley Park Foundation, which uses the house mainly for high-powered conferences on current affairs. Mike has a deep knowledge of the house, and his love and enthusiasm were evident. The most notable aspect of the house for most visitors is its association with Winston

Churchill. During the darkest days of the Second World War, he and his cabinet repeatedly used the house to transact business and to relax a little, at weekends.

Of particular interest to us, however, was the work of the stuccatori and in particular the contrast between the grand front hall and the saloon into which it leads. The hall was designed and its execution tightly controlled by James Gibbs (the architect of St Martinin-the-Fields) and William Kent, the dominant figure in British interior design at the time. All the decorative and spatial elements, and particularly the large allegorical figures and busts adorning the hall, are strictly disciplined to create a harmonious, balanced whole. By contrast, in the saloon, the plasterwork runs riot. It seems that the stuccatori led by Giuseppe Artari, together with the young Francesco Vassalli and Francesco Serena persuaded their patron to give them free rein. The results are exuberant, energetic... and just a little out of control! Our guide suggested that some of the heads were actual portraits - possibly of the stuccatoris' wives or mothers. Delicately-moulded drops of breast milk could be observed on the body of Ceres, the principal figure in the central roof roundel, while the faces of other figures suggested ecstasy - reminding us that when not in England, the stuccatori were busy created erotic figures for the walls and ceilings of the palaces of German prince-bishops.



There were, of course, many other rooms with fine paintings and furniture, not to mention the library which now serves as the conference room. We were also taken upstairs to see the bedrooms, used for visitors attending the conferences. Among them were the spacious bedrooms, with four poster beds, occupied by Churchill and his wife.

Finally, we had tea and biscuits in one of the rooms, before having the opportunity to step outside to enjoy the grounds in the warm, slightly misty, autumn sunshine.

New Helvetic Society: The tradition of L'Escalade in London

One of the most important events in the Genevan calendar is L'Escalade, commemorating the fateful event of December 1602 when the Duke of Savoy, Charles Emmanuel, attempted to take Geneva by surprise but suffered a crushing defeat at the hands of its citizens.

For over one hundred years, Genevans and friends have commemorated *L'Escalade* in London. December 2017 was no exception as 40 people gathered at the Embassy of Switzerland with our guests of honour, Mr and Mrs Voeffrey, both from Geneva. François Voeffrey is the Minister and Deputy Head of Mission at the Embassy.

Following a delicious three-course meal including the traditional vegetable soup and this year, Longeole, a local delicacy, guests sung

the *cé qué lainô*, the Genevan Hymn, lead by Gabriel Courvoisier, an opera singer also from Geneva. Last but not least, the event ended with the traditional smashing of the chocolate *marmite* (cauldron) filled with marzipan vegetables. Daniel Guenin smashed it to smithereens while reciting *Ainsi périrent les ennemis de la République* (Thus perish the enemies of the Republic). This refers to how Catherine Cheynel, better known as *Mère Royaume*, poured boiling hot vegetable soup on soldiers scaling the walls of the city.

Swiss Club Yorkshire: Jeffrey Long's Fundraising Trek went Viral

On October 24th, Jeffrey, 86 years old and a Yorkshire Swiss Club member, set off along the Thames footpath from the London Eye to walk a mile for each year of his life to raise £1000 for the Royal British Legion. Among the well-wishers for the journey were the Swiss Ambassador in London, the Vicar of Bingley, the Lord Major of Bradford and the Chief Commoner.

Maria Atkinson (Yorkshire Swiss Club) and Stephen Cooper (Support our Paras) walked the first few miles with Jeffrey. The former paratrooper, who has received an MBE for his fundraising efforts, walked in combat gear once he was out of central London. Despite sore feet due to chemotherapy, he reached the end of his journey in Caversham. 'My base was in Weybridge, Surrey and it took me up to two and half hours to get to and from the Thames each day. This has been the toughest I have done so far. I've really

had to push myself.' Jeffrey received an MBE for his previous fundraising efforts.

During his challenge, Jeffrey boarded a train at Windsor railway station on his way to the starting point of his river walk, when he met Paula Modeste, a NHS manageress, who asked why he was wearing full combat gear. After hearing about his plans and the £80 he had raised so far, she took a selfie and posted it to her Twitter and Facebook pages: 'I have generous friends'. Jason Manford, Comedian and TV presenter, shared Paula Modeste's Facebook post which went viral. Jeffrey has raised over £75000 with his sponsored walk thanks to the BBC.



the Swiss Review will devote a column to interesting sayings in our national languages, explained by a Swiss professional translator.

'Ma cha nids Fueferli uns Weggli ha!' is a common saying in the German-speaking part of Switzerland to explain that it is not possible to have everything. The words 'Weggli' is a typical Swiss soft bun/roll, brioche-like with a ridge down the middle (easy for breaking into two). A 'Fueferli' is the smallest denomination of Swiss currency coins i.e. Rappen. Traditionally, a 'Weggli' used to cost five Rappen in the olden days, so keeping that 5 Rappen piece and still getting the piece of bread essentially for free, This is not an option as nothing in life is free.

The French translation is: Vouloir le beurre et l'argent du beurre.

In Italian it can be translated as: Non puoi avere la botte piena e la moglie ubriaca.
